- (1) The shares indicated constitute restricted stock units that settle in common stock on a one share per unit basis. The restricted stock units vest in three equal installments on January 1, 2016, 2017 and 2018.  
Each performance stock unit represents a contingent right to receive one share of common stock of American Water Works Company, Inc. (the "Company"). The actual number of performance stock units that may be earned will be based on the Company's total stockholder return ("TSR") relative to the performance of the other companies in the Dow Jones U.S. Utility Total Return Index over a three-year performance period, beginning on January 1, 2015 and ending December 31, 2017. The number of performance stock units shown in column 5 is equal to the target number of performance stock units that may be earned.
- (3) Represents the end of the performance period to which the performance stock units relate.
- (4) The options vest in three equal installments on January 1, 2016, 2017 and 2018.
